Sovereign Ordinance no 16 of 31 December 2021 on the renewal of the temporary exercise of absolute power by the Sovereign Princess of Sancratosia

CLOE

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

Considering the Constitution of Sancratosia;

Considering the absence of citizens in the Principality of Sancratosia to accomplish the constitutional duties;

Considering the need for the Principality of Sancratosia to function until the establishment of a stable government;

We order:

Her Sovereign Highness Princess Cloe, Sovereign Princess of Sancratosia shall exercise all and every of the constitutional functions and powers.

The present Sovereign Ordinance shall be reviewed periodically every month on the next to last Friday of the month to assess the need to renew the Sovereign Ordinance.

Given in Our Princely Palace in Sancratosia on thirty-one December two thousand twenty-one.

Sovereign Ordinance no 17 of 4 January 2022 on the accession to member status in the Micronational Olympic Federation

Considering the Constitution of Sancratosia;

We order:

The Principality of Sancratosia is to become a member of the Micronational Olympic Federation.

The announce of this accession to membership shall be made public.

The Government Council shall be responsible for the application of the present Sovereign Ordinance.

Given in Our Princely Palace in Sancratosia on four January two thousand twenty-two.

Sovereign Ordinance no 18 of 4 January 2022 on the accession to observer status in the Micronational Assembly

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

Considering the Constitution of Sancratosia;

We order:

The Principality of Sancratosia is to become an observer state of the Micronational Assembly.

The announce of this accession to observer status shall be made public.

The Government Council shall be responsible for the application of the present Sovereign Ordinance.

Given in Our Princely Palace in Sancratosia on four January two thousand twenty-two.

Sovereign Ordinance no 19 of 5 January 2022 on the commissions charged with the elaboration of propositions of laws

CLOE

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

Considering the Constitution of Sancratosia;

We order:

ARTICLE 1.

It may be created, by a decree from the Minister of State, of commissions charged with the elaboration of propositions of laws to be submitted to the National Council, after examination by the State Council.

ARTICLE 2.

These commissions shall be presided by the Minister of State or a member of the Government Council ; they shall be composed, in addition to the Director of Legal Affairs, one or more members of the Government Council, designated by the Minister of State and members of the National Council designated by the president of this assembly.

On request by the commission, other public service member may be adjoined.

ARTICLE 3.

Each commission shall appoint a rapporteur.

The propositions of laws draft up shall be transmitted, accompanied by the report, to the Minister of State who will, if necessary, refer the matter to the State Council.

Sovereign Ordinance no 20 of 6 January 2022 on the creation of the Order of the Crown

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

With the desire to establish the Order of the Crown;

We order:

ARTICLE 1.

The Order of the Crown is established to reward and recognize exceptional accomplishments and services that bring prestige to the Principality of Sancratosia.

The Princess is the Grand Master of the Order.

This order can, in special cases, be attributed to foreigners.

ARTICLE 2.

The Order of the Crown is composed of one class, the Member.

ARTICLE 3.

All nominations into the Order belong to the Grand Master.

ARTICLE 4.

The decoration of the Order is formed of a red cross, bearing in the centre, in enamel, a depiction of the Honorific Crown of Sancratosia, surrounded by the motto of the Order : ATENI ▪ PRESTIJIA ▪ SERVI.

The ribbon of the order is red with two gold lines near the center.

ARTICLE 5.

The Grand Master only have the right, in the determined cases, to pronounce the revocation of one of its members.

ARTICLE 6.

The Order is administered by the Chancellor.

Sovereign Ordinance no 21 of 6 January 2022 on the creation of the Honourable Order of the Chives

CLOE

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

With the desire to establish the Honourable Order of the Chives;

We order:

ARTICLE 1.

The Honourable Order of the Chives is established to reward and recognize exceptional promotion of the culture of the Principality of Sancratosia.

The Princess is the Grand Master of the Order.

This order can, in special cases, be attributed to foreigners.

ARTICLE 2.

The Honourable Order of the Chives is composed of five classes, the Grand Collar, the Grand Officer, the Commander, the Officer and the Member.

A mandatory time of one year must be spent in each class before a promotion can be given.

ARTICLE 3.

All nominations into the Order belong to the Grand Master.

ARTICLE 4.

The decoration of the Order is formed of a silver cross, bearing in the centre, in enamel, a depiction of chives, surrounded by the name and the motto of the Order : PER LA PROMOVE DE LA CULTUR.

The ribbon of the order is green.

ARTICLE 5.

The Grand Master only have the right, in the determined cases, to pronounce the revocation of one of its members.

ARTICLE 6.

The Order is administered by the Chancellor.

Sovereign Ordinance no 22 of 6 January 2022 on the creation of the Honourable Order of the Martlet

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

With the desire to establish the Honourable Order of the Martlet;

We order:

ARTICLE 1.

The Honourable Order of the Martlet is established to reward and recognize exceptional promotion of the core values and principles of the Principality of Sancratosia.

The Princess is the Grand Master of the Order.

This order can, in special cases, be attributed to foreigners.

ARTICLE 2.

The Honourable Order of the Martlet is composed of five classes, the Grand Collar, the Grand Officer, the Commander, the Officer and the Member.

A mandatory time of one year must be spent in each class before a promotion can be given.

ARTICLE 3.

All nominations into the Order belong to the Grand Master.

ARTICLE 4.

The decoration of the Order is formed of a silver cross, bearing in the centre, in enamel, a depiction of a martlet, surrounded by the motto of the Order : PER LA PROMOVE DE LA VALUAS.

The ribbon of the order is blue.

ARTICLE 5.

The Grand Master only have the right, in the determined cases, to pronounce the revocation of one of its members.

ARTICLE 6.

The Order is administered by the Chancellor.

Given in Our Princely Palace in Sancratosia on six January two thousand twenty-two.

Sovereign Ordinance no 23 of 6 January 2022 on the creation of the Medals of Civil Service

CLOE

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

With the desire to establish the Medals of Civil Service;

We order:

ARTICLE 1.

The Medals of Civil Service are established to reward and recognize outstanding civic contribution that brought honour to the Principality of Sancratosia.

The Princess is the Sovereign of the Medals.

These medals can be attributed to foreigners.

ARTICLE 2.

All nominations of recipients of the medals belong to the Sovereign.

ARTICLE 3.

The medals are formed of a silver circle, bearing in the centre, in enamel, a depiction:

1. For the Medal of Meritorious Civil Service, of the greater coat of arms of Sancratosia, surrounded by the repeated motto : SERVI VALUADA.

The ribbon of the medal is white with three red lines on each side.

2. For the Medal of Distinguished Civil Service, of the middle coat of arms of Sancratosia, surrounded by the repeated motto : SERVI DISTINGUIDA.

The ribbon of the medal is white with two red lines on each side.

3. For the Medal of Mentioned Civil Service, of the lesser coat of arms of Sancratosia, surrounded by the repeated motto : SERVI NOTADA.

The ribbon of the medal is white with one red line on each side.

ARTICLE 4.

The Sovereign only have the right, in the determined cases, to pronounce the revocation of one of its recipients.

ARTICLE 5.

The Medals are administered by the Chancellor.

Sovereign Ordinance no 24 of 6 January 2022 on the creation of the Honours Commission

Considering the Constitution of Sancratosia;

We order:

ARTICLE 1.

The Honours Commission is instituted of which the members, chosen by Us, are named by Sovereign Ordinance.

ARTICLE 2.

The Honours Commission can advise:

1. On nominations and promotions within the orders, decorations and medals;
2. On other questions of interest of Our orders for which We demand advice.

Given in Our Princely Palace in Sancratosia on six January two thousand twenty-two.

Sovereign Ordinance no 25 of 6 January 2022 on the signature of the treaty between the Principality of Sancratosia and the Republic of Abenica

Considering the Constitution of Sancratosia;

Considering the communications received on 5 January 2022 from the Government of the Republic of Abenica;

We order:

The Principality of Sancratosia signs the *Treaty between the Principality of Sancratosia and the Republic of Abenica*.

The announce of the signature of this treaty shall be made public.

The Government Council shall be responsible for the application of the treaty and its diplomatic obligations.

LAWS*Law no 1 of 5 January 2022 on the national symbols*

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

We Promulgate this present law, that the National Council adopted in its session of 4 January 2022;

CHAPTER I. OF THE NATIONAL ANTHEM

ARTICLE 1.

The *Imno nasional de Sancratosia* is the official anthem of Sancratosia.

ARTICLE 2.

The official music of the National anthem is the one composed by AIVA on 27 November 2021.

ARTICLE 3.

The official lyrics that accompany the National anthem of Sancratosia are the ones composed by Princess Cloe of Sancratosia on 8 December 2021.

The lyrics of the National anthem are:

Vive nosa Prinsia
Monarcia bonvolente
Vive nosa Prinsesa
Ce nos ave nomida

La Prinsia de Sancratosia
Es la Stato de nos sonio
Un sonio de statia
E de un vive libre

CHAPTER II. OF THE NATIONAL BIRD

ARTICLE 4.

The National bird of Sancratosia is the *Branta canadensis*, commonly called *Canada goose*.

CHAPTER III. OF THE NATIONAL FLOWER

ARTICLE 5.

The National flower of Sancratosia is the *Allium schoenoprasum*, commonly called *Chives*.

CHAPTER IV. OF THE NATIONAL FOODS

ARTICLE 6.

The National drink of Sancratosia is *Coffee*.

ARTICLE 7.

The National dessert of Sancratosia is *Sucre à la crème*.

CHAPTER V. FINAL DISPOSITIONS

ARTICLE 8.

Regulatory dispositions determine, as needed, the conditions of application of the present law.

ARTICLE 9.

The present law is promulgated and executed as a law of the State.

The Government Council is responsible of its publication in the *Jornal de Sancratosia*.

Law no 2 of 5 January 2022 on the public recreational days

CLOE

We Promulgate this present law, that the

National Council adopted in its session of 4 January 2022;

CHAPTER I. OF THE PUBLIC RECREATIONAL DAYS

ARTICLE 1.

The public recreational days are to be considered with the same status as a normal Sunday.

ARTICLE 2.

The following dates shall be established as non-movable public recreational days:

- A. 1 January, New Year's Day
- B. 15 January, George Boeree Day
- C. 1 March, Sovereign Princess Day
- D. 21 March, Elefen Language Day
- E. 15 April, Duchess Maria I Day
- F. 1 May, Workers' Day
- G. 10 June, Chives Day
- I. 21 October, Emergence Day
- J. 1 December, Independence Day
- K. 25 December, Winter's Day

ARTICLE 3.

The following dates shall be established as movable public recreational days:

- A. First Monday of September, Goose Day
- B. Third Monday of February, Sancatosians' Day

Regulatory dispositions determine, as needed, the conditions of application of the present law.

ARTICLE 5.

The present law is promulgated and executed as a law of the State.

Law no 3 of 5 January 2022 on the nationality

CLOE

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

We Promulgate this present law, that the National Council adopted in its session of 4 January 2022;

CHAPTER I. OF THE ACQUISITION OF
SANCRATOSIAN NATIONALITY

ARTICLE 1.

Naturalization within Sancratosia can be requested by a foreigner who is aged thirteen or more.

The nationality is given by Sovereign Ordinance after summary examination of the application by the foreigner, especially concerning the immediate renunciation of foreign nationality.

The nationality can be acquired by a foreigner who cannot renunciate their nationality, by virtue of a foreign national law.

ARTICLE 2.

The nationality can also be acquired by a foreigner who the Sovereign Princess deems dignified to receive such a nationality.

CHAPTER II. OF THE LOSS OF
SANCRATOSIAN NATIONALITY

ARTICLE 3.

Sancratosian nationality is lost:

1. When acquiring the nationality of a foreign country;
2. When an individual declines their Sancratosian nationality in the terms foreseen by the law.

CHAPTER III. OF THE DECLARATIONS OF NATIONALITY

ARTICLE 4.

The delay for the acquisition of Sancratosian nationality is no more than one month from the application made by the foreigner.

If the aforementioned delay is not respected, the applicant can refer their case to the courts of Sancratosia and enjoys the same rights and privileges of Sancratosians for the duration of the procedures.

ARTICLE 5.

In a delay of six months from the acquisition of Sancratosian nationality, the Sovereign Princess can, by Sovereign Ordinance after consulting the State Council, oppose the acquisition of Sancratosian nationality.

In the case of opposition, the person is considered to have never been of Sancratosian nationality.

ARTICLE 7.

The present law is promulgated and executed as a law of the State.

The Government Council is responsible of its publication in the *Jornal de Sancratosia*.

TREATIES

Treaty between the Principality of Sancratosia and the Republic of Abenica

Treaty on Mutual Recognition and Cultural

Cooperation between the Principality of Sancratosia and the Republic of Abenica;

The Principality of Sancratosia and the Republic of Abenica, hereinafter referred to as “the Parties”;

Considering the shared values of democracy, individual freedom and equality before the Law;

Considering their shared commitment to increase cultural production and values in defense of Human Rights;

Desiring to conclude an agreement to establish mutual recognition of the Parties;

Taking into account the enhancement of bilateral cooperation that will contribute to promote greater development and welfare in the Parties;

Agree to the following :

ARTICLE 1. OBJECT AND SCOPE OF APPLICATION

The object of this Agreement is the mutual recognition between the Parties of the authorities, political regime, structure and legislation, resulting in the Parties mutually recognizing each other as sovereign countries, with independent existence.

ARTICLE 2. TERRITORIALITY AND LEGISLATION

The Parties recognize and respect the territorial limits, national sovereignty, institutional legitimacy as well as their own laws and customs, based on the norms of International Law and the Universal Declaration of Human Rights.

ARTICLE 3. BILATERAL CULTURAL COOPERATION

The Parties undertake to establish embassies, with an official at the head, to deepen, coordinate and develop cultural actions and events for the benefit of the dissemination of the artistic creations of their citizens.

ARTICLE 4. EXTERNAL COOPERATION

The Parties undertake to maintain, through their respective embassies, a channel of bilateral communication in the field of Foreign Affairs, in order to coordinate joint actions for the benefit of deepening bilateral relations and cooperating in the defense of democracy, individual freedoms and Human Rights

throughout the world.

ARTICLE 5. INSTITUTIONAL NEUTRALITY

On the basis that the Parties are governed by democratic systems, they agree not to intervene in internal affairs such as changes of government or ideological currents, respecting institutional decisions, as long as they are based on democratic processes.

ARTICLE 6. PUBLICITY OF THE TREATY

The Parties agree to make this Agreement public, as a sign of goodwill and mutual cooperation in diplomatic matters.

ARTICLE 7. VALIDITY OF THE AGREEMENT

The Parties agree that this Agreement shall be legally effective from the moment of its publication in the respective national official gazettes, provided that all sections of the Agreement are complied with, and provided that the bilateral communication channel is open and uninterrupted. In case of interruption of communications for a period exceeding 6 months, the Agreement may be suspended until contact is resumed.

Governmental directive on the boycott of the 2022 FIFA World Cup organized in Qatar

Considering the alleged slavery and human rights abuses of migrant workers committed by the government of the State of Qatar;

Considering that the policies pursued by the government have led to the death of around 1,200 workers;

Considering the call to boycott initiated by the Republic of Abenica;

The Government of Sancratosia issues the

following directive:

The Principality of Sancratosia officially joins the call to boycott the 2022 FIFA World Cup organized in the State of Qatar.

The Principality of Sancratosia officially invites other nations to apply a similar boycott.

The announce of this official boycott shall be made public.
