## LAWS

*Law no 4 of 13 January 2022 on the oaths*

CLOE

BY THE WILL OF THE PEOPLE  
SOVEREIGN PRINCESS OF SANCRATOSIA

**We Promulgate this present law, that the National Council adopted in its session of 12 January 2022;**

### CHAPTER I. OF THE OATH OF NATIONALITY

#### ARTICLE 1.

The oath of nationality shall be the following:

I swear to be faithful to Her Sovereign Highness Princess Cloe, Sovereign Princess of Sancratosia and that I will faithfully respect the Constitution and the laws of Sancratosia.

### CHAPTER II. OF THE OATHS OF OFFICE

#### ARTICLE 2.

The oath of office for the Members of the Government Council, the State Council, the Crown Council and the President of the National Council shall be the following:

I promise to fulfill my duties with integrity, impartiality and professionalism.

#### ARTICLE 3.

The oath of office for the Members of the National Council and the Municipal Council shall be the following:

I promise to fulfill my role by considering the interests of the Principality of Sancratosia and of Sancratosian citizens above my own.

### CHAPTER III. OF THE OATHS OF THE SOVEREIGN FAMILY

#### ARTICLE 4.

The oath of inauguration for the Sovereign of Sancratosia shall be the following:

I swear to be faithful to the Principality of Sancratosia, to its Constitution and to its laws, to maintain the national independence and integrity of the territory, as well as the collective and individual rights and freedoms.

#### ARTICLE 5.

The oath of inauguration for the Regent of the Sovereign of Sancratosia shall be the following:

I swear to be faithful to the Sovereign and to the Principality of Sancratosia, to its Constitution and to its laws, to maintain the national independence and integrity of the territory, as well as the collective and individual rights and freedoms.

### CHAPTER IV. FINAL DISPOSITIONS

#### ARTICLE 6.

Regulatory dispositions determine, as needed, the conditions of application of the present law.

#### ARTICLE 7.

The present law is promulgated and executed as a law of the State.

The Government Council is responsible of its publication in the *Jornal de Sancratosia*.

**We Promulgate this present law, that the National Council adopted in its session of 12 January 2022;**

CHAPTER I. OF THE PROVISIONS AGAINST  
DISCRIMINATION

ARTICLE 1.

No one may discriminated against on the basis of their social origin, their economic situation, their place of origin, their ethnicity, their sex, their gender identity and expression, their sexual orientation, their religion, political or ideological convictions and their social and physical conditions by an individual, a private or public society or by the public authorities.

ARTICLE 2.

A right attributed to a Sancratosian citizen either by the uncodified or codified laws of Sancratosia, by the judgements of the courts, or by any public authority of Sancratosia is reputed to be granted to all Sancratosian citizens without discrimination.

CHAPTER II. FINAL DISPOSITIONS

ARTICLE 3.

Regulatory dispositions determine, as needed, the conditions of application of the present law.

ARTICLE 4.

The present law is promulgated and executed as a law of the State.

The Government Council is responsible of its publication in the *Jornal de Sancratosia*.

**TREATIES**

*Treaty between the Principality of Sancratosia and the Principality of Veraburgo*

The Principality of Sancratosia and the Principality of Veraburgo, hereafter called "the Nations", in accordance with the principles of international law;

**Agree to the following :**

ARTICLE 1.

The Nations recognize the sovereignty and independence of the other.

The Nations will not recognize a claim of sovereignty or independence that is concurrent with the ones claimed by the Nations.

ARTICLE 2.

The Nations establish formal diplomatic relations.

The Nations shall notify the other of any changes in administration or governance of foreign affairs in their respective governments.

ARTICLE 3.

The Nations recognize and reaffirm that both Nations are separate and equal sovereign entities.

ARTICLE 4.

The Nations adhere to the principles of non-intervention in the internal affairs and general administration of the other.

ARTICLE 5.

The Treaty comes into effect on the date of publication by the Nations, but no latter than ten days after the signature by the competent authorities of the Nations.

*Treaty between the Principality of Sancratosia and the*

*Democratic Republic of Denbar*

The Principality of Sancratosia and the Democratic Republic of Denbar, hereafter called “the Nations”, in accordance with the principles of international law;

**Agree to the following :**

## ARTICLE 1.

The Nations recognize the sovereignty and independence of the other.

The Nations will not recognize a claim of sovereignty or independence that is concurrent with the ones claimed by the Nations.

## ARTICLE 2.

The Nations establish formal diplomatic relations.

The Nations shall notify the other of any changes in administration or governance of foreign affairs in their respective governments.

## ARTICLE 3.

The Nations recognize and reaffirm that both Nations are separate and equal sovereign entities.

## ARTICLE 4.

The Nations adhere to the principles of non-intervention in the internal affairs and general administration of the other.

## ARTICLE 5.

The Treaty comes into effect on the date of publication by the Nations, but no latter than ten days after the signature by the competent authorities of the Nations.

*Treaty between the Principality of Sancratosia and the Kingdom of Sildavia*

The Sancratosians and the Sildavians;

For the common desire to maintain and promote their cultures and traditions with fundamental respect for other cultures and traditions, anxious to exalt the common characteristics among the peoples mentioned and desirous of together, to create bonds that make this bilateral relationship a highlight in the Concert of Nations;

In order to maintain peace and stability, to promote prosperity and well-being and, at the same time, to guarantee the security and rest of the interests of the parties involved, they have, with the approval of Her Majesty, the Queen of Sildavia, and Her Sovereign Highness, The Sovereign Princess of Sancratosia the conclusion of this treaty which provides for diplomatic recognition between the parties and the establishment of a diplomatic relationship;

In view of this important act, which will come into force in its promulgation on 14 January 2022, the parties decided to conclude a treaty and, to that end, themselves, through mutual deliberation;

**Agree to the following :**

## ARTICLE 1.

The governments of Sancratosia and Sildavia declare in an irrevocable and irreversible way to recognize each other as the legitimately established governments, sovereign and independent nations, in their declared territorial denominations. Such recognition may be justifiably terminated or suspended, or if one of the signatory states ceases to exist.

## ARTICLE 2.

The governments of Sancratosia and Sildavia declare irrevocably and irreversibly to waive any right or intention to intervene in the internal affairs of both countries.

## ARTICLE 3.

The two countries are committed to recognizing and respecting the government, the structure and administrative changes in both countries, should they occur.

## ARTICLE 4.

The two countries are committed to respecting the culture and conventions of both countries.

ARTICLE 5.

The two countries are committed to building a strong and cooperative relationship.

ARTICLE 6.

This treaty, having been approved by the signatory parties, Her Sildavian Majesty the Queen of Sildavia and Her Sovereign Highness, The Sovereign Princess of Sancratosia comes into force as from 14 January 2022.
