*Sovereign Ordinance no 31 of 14 January 2022 on the creation of the Cornelis George Boeree Medal for Innovation and Creativity*

BY THE WILL OF THE PEOPLE  
SOVEREIGN PRINCESS OF SANCRATOSIA

*With the desire to establish the Cornelis George Boeree Medal for Innovation and Creativity;*

We order:

#### ARTICLE 1.

The Cornelis George Boeree Medal for Innovation and Creativity is established to reward and recognize innovative and/or creative initiatives in Sancratosia and abroad.

The Princess is the Sovereign of the Medal.

This medal can be attributed to foreigners.

#### ARTICLE 2.

All nominations of recipients of the medal belong to the Sovereign.

#### ARTICLE 3.

The medal is formed of a silver circle, bearing in the centre, a depiction of C. George Boeree, surrounded by the following inscription : MEDALIA CORNELIS GEORGE BOEREE PER LA INOVA E LA CREOSIA ▪ SANCRATOSIA ▪

The ribbon of the medal is blue, green, yellow, orange and red, of the colours of the flag of Lingua Franca Nova.

#### ARTICLE 4.

The Sovereign only have the right, in the determined cases, to pronounce the revocation of one of its recipients.

#### ARTICLE 5.

The Medal is administered by the Chancellor.

BY THE WILL OF THE PEOPLE  
SOVEREIGN PRINCESS OF SANCRATOSIA

*Considering the Constitution of Sancratosia;*

*Considering the communications received on 11 January 2022 from the Government of the Imperial City of Vurmond;*

**We order:**

The Principality of Sancratosia signs the *Treaty between the Principality of Sancratosia and the Imperial City of Vurmond*.

The announce of the signature of this treaty shall be made public.

The Government Council shall be responsible for the application of the treaty and its diplomatic obligations.

## **TREATIES**

*Treaty between the Principality of Sancratosia and the Imperial City of Vurmond*

The Principality of Sancratosia and the Imperial City of Vurmond, hereafter called "the countries", in accordance with the principles of international law;

**Agree to the following :**

ARTICLE 1.

Recognize the sovereignty of the two countries and recognize their independence.

ARTICLE 2.

Both countries share a vision for mutual development and help each other in need.

ARTICLE 3.

The two countries may provide assistance if deemed necessary when each other's dangers arise.

ARTICLE 4.

The two countries can help each other culturally and economically support each other and discuss development through it.

ARTICLE 5.

Both countries oppose and do not participate in micronational wars.

ARTICLE 6.

Both countries can recognize each other's capabilities and provide support for mutual support exchanges.

ARTICLE 7.

The two countries can take the necessary steps to build friendship with each other.

ARTICLE 8.

The two countries may send ambassadors between countries.

ARTICLE 9.

The two countries can share the best policies to facilitate each other's development and exchanges.

ARTICLE 10.

The state should give advance notice when the national symbol or government changes rapidly.

ARTICLE 11.

Both countries can share their plans for the future.

ARTICLE 12.

---

The two countries can complement each other's technologies and exchange opinions.

ARTICLE 13.

The two countries are mutually exclusive, and the treaty is automatically abolished three months after the other party decides to revoke it.
