**TREATIES**

*Treaty between the Principality of Sancratosia and the Principality of Carnovia*

Treaty for the Arrangement of Diplomatic Relations between the Signatory States

The Principality of Sancratosia and the Principality of Carnovia, hereafter called "the parties", in accordance with the principles of international law;

Agree to the following :

**PREAMBLE**

The states of the Principality of Carnovia and the Principality of Sancratosia have decided to take the initiative to establish diplomatic relations with the full right to mutual recognition as a sovereign state entity. Both parties undertake to maintain and respect the political apparatus of both parties and their legal environment. With this treaty, the Principality of Carnovia formally recognizes the Principality of Sancratosia as a sovereign nation, and vice versa. At the same time, both sides undertake to resolve possible conflicts through diplomatic debate, thus maintaining

a fragile peace.

ARTICLE 1.

The Principality of Carnovia and Principality of San cratosia mutually respect the political systems and state apparatus of the signatory states. They undertake not to interfere in internal affairs unless absolutely necessary, which is considered to be a threat to statehood (the intervention state must give its consent to intervention).

ARTICLE 2.

Both countries are recognized as sovereign nations on the basis of the free right to self-determination.

ARTICLE 3.

The priority of the signatory states is to maintain peace in their territories, so it is unacceptable for one of the signatory states to support or support the efforts of enemy troops or terrorist organizations.

ARTICLE 4.

Signatory states may, upon further agreement, share research, trade agreements, exchange currencies and passports, and other items.

ARTICLE 5.

The treaty enters into force on the day of its signing and is subject to ratification.

*Treaty between the Principality of San cratosia and the Union of the Provinces of Columbia*

The Principality of San cratosia and the Principality of Carnovia, hereafter called “the signatory states”, in accordance with the principles of international law;

Agree to the following :

ARTICLE 1.

The Union of the Provinces of Columbia and the Principality of San cratosia ratify the signing of a mutual recognition treaty. Both signatory states undertake to recognize and respect their mutual existence, collaborate with each other and protect their best interests, both common and individual, to guarantee the maintenance of good micronational diplomatic practices.

CLOE

*Treaty between the Principality of San cratosia and the Kingdom of Queensland*

The Principality of San cratosia and the Kingdom of Queensland, hereafter called “the parties”, in accordance with the principles of international law;

Agree to the following :

ARTICLE 1.

By signing this Diplomatic Alliance Contract, The Principality of San cratosia and The Kingdom of Queensland formally recognize the sovereignty and independence of both states until the dissolution of one or all parties.

ARTICLE 2.

It is through this mutual recognition that both states establish formal diplomatic relations, respecting the already-established conventions and declarations.

ARTICLE 3.

Through this recognition of diplomatic relations, it will be established that both states will remain separate and equally independent with respect to the national legislature and foreign affairs and that this document establishes relations only between the signatory micronation of the present treaty.

ARTICLE 4.

Both States recognize that these relationships must be built on the basis of cooperation and perpetual

peace between each state and that independent citizens of both nations respect and recognize the sovereignty, laws and conventions of the other, as well as specificities of each micronation and their micronational traditions and practices.

ARTICLE 5.

In case of violation of this Treaty by either side, the signatories are to discuss the situation through diplomatic dialogue; failing this, the treaty shall be considered void.
