BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

*Considering the Constitution of Sancratosia;
Considering the communications received on 23 April 2022 from the Government of the Republic of Poggio Corese;*

We order:

The Principality of Sancratosia signs the *Treaty between the Principality of Sancratosia and the Republic of Poggio Corese*.

The announce of the signature of this treaty shall be made public.

The Government Council shall be responsible for the application of the treaty and its diplomatic obligations.

Given in Our Princely Palace in Sancratosia on fifteen May two thousand twenty-two.

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

Considering the Constitution of Sancratosia;

We order:

Mister Eujen Smit is nominated Our Government Councillor-Minister.

The Secretary of State shall be responsible for the application of the present Sovereign Ordinance.

Law no 8 of 18 May 2022 modifying Law no 2 of 5 January 2022 on the public recreational days

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

We Promulgate this present law, that the National Council adopted in its session of 17 May 2022;

CHAPTER I. OF THE PUBLIC RECREATIONAL DAYS

ARTICLE 1.

In article 3 is added the following :

B. Fourth Friday of May, Friendship's Day

CHAPTER II. FINAL DISPOSITIONS

ARTICLE 2.

Regulatory dispositions determine, as needed, the conditions of application of the present law.

ARTICLE 3.

The present law is promulgated and executed as a law of the State.

The Government Council is responsible of its publication in the *Jornal de Sancratosia*.

Promulgated in Our Princely Palace in Sancratosia on eighteen May two thousand twenty-two.

TREATIES

Treaty between the Principality of Sancratosia and the Republic of Poggio Corese

The Principality of Sancratosia and the Republic of Poggio Corese, in accordance with the principles of

international law;

Agree to the following :

ARTICLE 1.

The Republic of Poggio Corese and the Principality of Sancratosia agree to recognize each other as independent and sovereign nations.

ARTICLE 2.

The Republic of Poggio Corese and the Principality of Sancratosia establish diplomatic relations based on friendship and mutual cooperation between the two countries.

ARTICLE 3.

The treaty enters into force with the signature of the two heads of state.

Given in Our Princely Palace in Sancratosia on fifteen May two thousand twenty-two.
