### We order:

The Principality of Sancratosia signs the *Treaty between the Principality of Sancratosia and the Principality of Moscha*.

The announce of the signature of this treaty shall be made public.

The Government Council shall be responsible for the application of the treaty and its diplomatic obligations.

### We order:

The Principality of Sancratosia signs the *Treaty between the Principality of Sancratosia and the Republic of Arkazja*.

The Government Council shall be responsible for the application of the treaty and its diplomatic

obligations.

BY THE WILL OF THE PEOPLE  
SOVEREIGN PRINCESS OF SANCRATOSIA

*Considering the Constitution of Sancratosia;*

**We order:**

Maher Khedher is nominated Our Ambassador-at-large based in the United Kingdom.

The Councillor-Minister of Foreign Relations shall be responsible for the application of the present Sovereign Ordinance.

Is revoked from this date:

- Sovereign Ordinance no 58 of 4 May 2022 on the nomination of the Ambassador of Sancratosia to the United Kingdom

## **TREATIES**

*Treaty between the Principality of Sancratosia and the Principality of Moscha*

The Principality of Sancratosia and the Principality of Moscha, hereafter called "the Nations", in accordance with the principles of international law;

Agree to the following :

ARTICLE 1.

The Nations agree on mutual recognition of

their existence as a micro-nation, both legal and constitutional with full sovereignty, freedom and independence.

ARTICLE 2.

The Nations agree on mutual recognition of their symbols, territories, institutions, legal system and legitimacy of their authority and established laws.

ARTICLE 3.

The Nations agree on mutual recognition of free diplomatic exchange with other Nations, States, Micro-nations and of joining micro-national organizations without this binding the other party signatory of this treaty.

ARTICLE 4.

The Nations commit to the mutual defense of integrity, sovereignty, independence and their national reality against any aggression from another Nation or Micro-nation.

ARTICLE 5.

The Nations undertake to resolve their differences through dialogue and diplomatic channels.

ARTICLE 6.

The Nations commit, in the event of a declaration of war on another micro-nation, in the entire revision of this treaty.

ARTICLE 7.

The Nations undertake and agree to make this recognition public.

ARTICLE 8.

This Treaty shall be ratified, in accordance with the institutional procedure of each of the micro-nations and shall enter into force on the day of its signature.

ARTICLE 9.

Each signatory party undertakes to give it as much publicity as possible in its territory.

## ARTICLE 10.

Once this treaty has been ratified, it will remain in force indefinitely, as long as it is not denounced in writing by one of the signatory parties.

## ARTICLE 11.

In the event of demonstrated inactivity and without prior notice from one of the signatory parties for a period of more than two years, this treaty will be considered cancelled.

## ARTICLE 12.

If permanent inactivity is announced by official communication and verified by one of the signatory parties, the Treaty will be immediately cancelled.

*Treaty between the Principality of Sancratosia and the Republic of Arkazja*

The Principality of Sancratosia and the Republic of Arkazja, hereafter called "the signatories", in accordance with the principles of international law;

Agree to the following :

## ARTICLE 1.

Under the direct jurisdiction of the President of the Republic of Arkazja, Natt Falkenhausen, and of the Sovereign Princess of the Principality of Sancratosia, Cloe, this document details the mutual recognition between the Republic of Arkazja and the Principality of Sancratosia.

Both signatories will recognize the other's territorial claims, and they both will agree to respect such claims.

Below are the signatures of the leaders or diplomats of these nations, signifying that they on the behalf of their nations agree to the terms of this document and that they will not abandon the terms of this document unless both nations formally agree to dissolve it.
