SOVEREIGN ORDINANCES

Sovereign Ordinance 83 of 21 August 2022 on the creation of the Medal for participation at the 2022 Digi Micro Summit

CLOE

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

With the desire to establish the Medal for participation at the 2022 Digi Micro Summit;

We order:

ARTICLE 1.

The Medal for participation at the 2022 Digi Micro Summit is established to mark the participation of registered nations at the 2022 Digi Micro Summit, which was held jointly by the Democratic Republic of Satoshi and the Principality of Sancratosia.

The Princess is the Sovereign of the Medal.

This medal can be attributed to foreigners.

ARTICLE 2.

All nominations of recipients of the medal belong to the Sovereign.

ARTICLE 3.

The medal is formed of a silver circle, bearing in the centre, a depiction of the Digi Micro Summit logo, surrounded by the following inscription : MEDALIA PER LA PARTISIPA A DIGI MICRO SUMMIT 2022 ▪ 19 AGOSTO 2022 - 21 AGOSTO 2022 ▪

The ribbon of the medal is red, bearing in the center a band of light pink.

ARTICLE 4.

The Sovereign only have the right, in the determined cases, to pronounce the revocation of one of its recipients.

ARTICLE 5.

The Medal is administered by the Chancellor.

We order:

The Principality of Sancratosia revokes the *Treaty between the Principality of Sancratosia and the Democratic Republic of Denbar.*

The announce of the revocation of this treaty shall be made public.

Given in Our Princely Palace in Sancratosia on twenty-one August two thousand twenty-two.

Sovereign Ordinance no 85 of 24 August 2022 on the granting of Sancratosian nationality

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

*Considering the Constitution of Sancratosia;
Considering the Law no 3 on the nationality;*

*Considering the Article 12 of the Civil Code;
Considering the petition made by Mister Alfredo Mulè on 1 August 2022;*

We order:

Mister Alfredo Mulè is naturalized Sancratosian subject.

He is thus conferred Sancratosian nationality and enjoys the rights and privileges of this nationality.

The Ministry of State shall be responsible for the application of the present Sovereign Ordinance.

Given in Our Princely Palace in Sancratosia on twenty-four August two thousand twenty-two.

Sovereign Ordinance 86 of 24 August 2022 on the signature of the Chyšë Charter

Considering the Constitution of Sancratosia;

We order:

The Principality of Sancratosia is to become a signatory of the Chyšë Charter.

The announce of this signature shall be made public.

The Government Council shall be responsible for the application of the present Sovereign Ordinance.

Given in Our Princely Palace in Sancratosia on twenty-four August two thousand twenty-one.

Sovereign Ordinance no 87 of 25 August 2022 on the signature of the treaty between the Principality of Sancratosia and the Grand Emirate of Raphania

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

*Considering the Constitution of Sancratosia;
Considering the communications received on 7 June 2022 from the Government of the Grand Emirate of Raphania;*

We order:

The Principality of Sancratosia signs the *Treaty between the Principality of Sancratosia and the Grand Emirate of Raphania*.

The announce of the signature of this treaty shall be made public.

The Government Council shall be responsible for the application of the treaty and its diplomatic obligations.

Given in Our Princely Palace in Sancratosia on twenty-five August two thousand twenty-two.

CLOE

TREATIES

Treaty between the Principality of Sancratosia and the Grand Emirate of Raphania

The Principality of Sancratosia and the Grand Emirate of Raphania, hereafter called "the Nations", in accordance with the principles of international law;

Agree to the following :

ARTICLE 1.

The Nations recognize the sovereignty and independence of the other.

The Nations will not recognize a claim of sovereignty or independence that is concurrent with the ones claimed by the Nations.

ARTICLE 2.

The Nations establish formal diplomatic relations.

The Nations shall notify the other of any changes in administration or governance of foreign affairs in their respective governments.

ARTICLE 3.

The Nations recognize and reaffirm that both Nations are separate and equal sovereign entities.

ARTICLE 4.

The Nations adhere to the principles of non-intervention in the internal affairs and general administration of the other.

ARTICLE 5.

The Treaty comes into effect on the date of publication by the Nations, but no latter than ten days after the signature by the competent authorities of the Nations.

Given in Our Princely Palace in Sancratosia on eight June two thousand twenty-two.
