We order:

Is instituted, under Our patronage, a Sancratosian Micronational Olympic Committee which has for object to prepare and to assure the representation of the Principality at the Micronational Olympic Games organized by the Micronational Olympic Federation.

The Government Council shall be responsible for the application of the present Sovereign Ordinance.

Sovereign Ordinance no 111 of 15 November 2022 on the creation of the Sancratosian Sports Confederation

BY THE WILL OF THE PEOPLE
SOVEREIGN PRINCESS OF SANCRATOSIA

Considering the Constitution of Sancratosia;

We order:

ARTICLE 1.

Is instituted a Sancratosian Sports Confederation which has for mission:

1. to define a program of renovation, amelioration, coordination and of control of sports activities;
2. to establish, within the framework of this program, the conditions and the rules for the attribution of subsidies to the sports federations in order to create a sporting elite capable of representing the Principality in international competitions;
3. in a general manner, to give its advice on every question interesting for the organization of sporting competitions in the Principality or abroad.

ARTICLE 2.

Under the presidency of the Government Councillor-Minister of Society, this commission is thus composed of:

1. the Mayor of Sancratosia as vice-president;
2. three National Councillors;
3. the Municipal Councillor assigned to sporting affairs;
4. the director of the Department of Sports;
5. the President of the Sancratosian Micronational Olympic Committee;
6. four people designated for their competence in sporting affairs by a Ministerial Decree.

ARTICLE 3.

The Government Council shall be responsible for the application of the present Sovereign Ordinance.

Considering the Law no 3 on the nationality;
Considering the Article 12 of the Civil Code;
Considering the petition made by Mister Nazib Bin Omar on 24 August 2022;*

We order:

Mister Nazib Bin Omar is naturalized Sancratosian subject.

He is thus conferred Sancratosian nationality and enjoys the rights and privileges of this nationality.

The Ministry of State shall be responsible for the application of the present Sovereign Ordinance.

Given in Our Princely Palace in Sancratosia on nineteen November two thousand twenty-two.
