SOVEREIGN ORDINANCES

Sovereign Ordinance no 129 of 13 April 2023 on the entry conditions of foreigners in the Principality

CLOE BY THE WILL OF THE PEOPLE SOVEREIGN PRINCESS OF SANCRATOSIA

Considering the Constitution of Sancratosia;

We order:

CHAPTER I. CONDITIONS OF ENTRY IN THE

TERRITORY

ARTICLE 1.

Any foreigner aged 13 or older, that wants to enter in the territory of the Principality, must be in possession of a valid passport, or of any travel or identification document, and bearing the stamps, visas and authorizations permitting the entry in Canada.

Canadian residents must have an identification card issued by the Canadian administration or the administration of a province or a territory.

ARTICLE 2.

Any foreigner aged 13 or older, that wants to enter in the territory of the Principality, must request a visiting visa upon entering in Sancratosia, unless they are not required to, according to the visa policy of Sancratosia.

Visas are available for a duration of 3, 5 or 7 days.

ARTICLE 3.

Visas can be extended upon request to the Ministry of Territory at least 1 day before its expiration.

CHAPTER II. FINAL DISPOSITIONS

ARTICLE 4.

The Government Council shall be responsible for the application of the present Sovereign Ordinance.

Sovereign Ordinance no 130 of 14 April 2023 on the signature of the treaty between the Principality of Sancratosia and the Republic of Upper Shwartz Morgen Lorgen Land

CLOE BY THE WILL OF THE PEOPLE SOVEREIGN PRINCESS OF SANCRATOSIA

Considering the Constitution of Sancratosia; Considering the communications received on 2 March 2023 from the Government of the Republic of Upper Shwartz Morgen Lorgen Land;

We order:

The Principality of Sancratosia signs the *Treaty* between the Principality of Sancratosia and the Republic of Upper Shwartz Morgen Lorgen Land.

The announce of the signature of this treaty shall be made public.

The Government Council shall be responsible for the application of the treaty and its diplomatic obligations.

Given in Our Princely Palace in Sancratosia on fourteen April two thousand twenty-three.

TREATIES

Treaty between the Principality of Sancratosia and the Republic of Upper Shwartz Morgen Lorgen Land

The Principality of Sancratosia and the Republic of Upper Shwartz Morgen Lorgen Land, hereafter called "the Nations", in accordance with the principles of international law;

Agree to the following:

ARTICLE 1.

This treaty states the official relations between the Nations and the mutual recognition as Sovereign and Free Micronations.

ARTICLE 2.

The Nations undertake to extend their corporate and cultural relations, supporting each other in foreign policy, unless there is a state of conflict based on the own fundamental principles.

ARTICLE 3.

Both Nations agree to publicly make this known on webpages, social media and (if applicable) in traditional media such as newspapers, TV and radio.

ARTICLE 4.

Both Nations acknowledge these relationships to be built on cooperation and perpetual peace between each State, and that the independent citizens of both Nations respect and recognize the sovereignty, laws and conventions of the other.

ARTICLE 5.

This treaty envisages the existence of mutually beneficial contacts and collaborations, development of bilateral dialogue in cultural, social and humanitarian fields. Agreements, stating the conditions of such contacts and collaborations, can be signed independently or as an addition to this treaty.

ARTICLE 6.

This treaty is signed for an unlimited period of time, but can be terminated by both parties' agreement.

ARTICLE 7.

This treaty shall formally come into effect immediately after the treaty has been ratified by the governments of the two Nations and it can be dissolved by either Nation, with prior notification, not later than two weeks before the planned date of dissolution.

NATIONAL POLICIES

Visa policy of the Principality of Sancratosia

PREAMBLE

Although travel to Sancratosia remains complicated, it is believed that having a visa policy will facilitate travel in the future.

This visa policy aims to provide a proper guideline for the establishment of visa restrictions, exemptions and everything related to the entry of people in the Sancratosian territory.

Sancratosia recognizes that the imposition of visa restrictions is not driven by security concerns or to curb illegal immigration, but rather to provide some foresight on the entry of foreigners in the territory of the Principality.

ENTRY AND DURATION PERIOD

Sancratosia offers multiple-entry visitation visas that have a duration of 3, 5 or 7 days. The visa may be extended after request to the Ministry of Territory at least 1 day before the expiration of the visa.

Having a visitation visa does not guarantee entry in the Principality. The border crossing authorities make the final determination to allow entry, and may cancel a visa at the border.

Entry in Sancratosia is also impossible without entry in Canada. As such, requirements for entry in Canada have to be considered by foreigners.

VISA REFUSAL

Foreigners may be refused a visa if they do not meet the requirements for admission or entry:

> Having committed fraud, deception, or misrepresentation in their current application as well as in a previous application;

Having a criminal record, having criminal charges pending;

Being considered a threat to national security;

Having previous visa violations, even if said violations did not happen in the Principality;

Failing to demonstrate intent to return to their home country;

Failing to provide sufficient documents to prove eligibility for the visa.

These requirements may be used to refuse entry to foreigners who do not need a visa.

VISA EXEMPTIONS

Holders of valid travel documents issued by certain nations are able to visit Sancratosia without obtaining a visa for a period of up to 7 days.

Visa exemptions are granted to macronations based on their alignment with Sancratosian values, their visa free access to Canada, their Henley Passport Index.

Visa exemptions are granted to micronations based on the Foreign policy of the Principality of Sancratosia.
